**Registration Terms and Conditions**

**Registration Fee**

The Registration Fee includes entry to all events as outlined in the Seminar program unless otherwise specified. The fee does not include accommodation, non-program related meals, travel or any other expenses that may be incurred by delegates.

**Payment Terms**

Registration fees are due and payable at the time of registration.

**Cancellation/Refund**

- All requests for refunds must be submitted to Roxanne Barre, Conference and Events Registration Administrator, in writing by mail, fax or e-mail. Refunds may not be processed until after the close of the Seminar. Registration fees are non-transferable to another CanWEA event.

- Requests received by September 10, 2010 receive a full refund less \$150 administrative fee per person.

- **No refunds** will be made for cancellations received after September 10, 2010 or no-shows.

**Substitutions**

Substitutions will be processed on a complimentary basis. Substitutions will not be accepted if the registered delegate has already checked in on site.
